**AGREEMENT** by and between, the American Society for Microbiology (ASM), a not-for-profit, tax-exempt association with its principal office at 1752 N Street, N.W., Washington, D.C. 20036 ("Licensor"), and [name] \_\_\_\_\_, [address] \_\_\_\_\_ ("Licensee") (the two entities collectively referred to as "the Parties"), has been executed as of the Effective Date set forth on the Cover Sheet attached hereto.

**NOW, THEREFORE**, in consideration of the mutual promises contained herein and for good and valuable consideration, the Parties agree as follows:

**1. Definitions**

**1.1 ASM Press eBooks Collections.** Compilations of ASM-Press-published books grouped by individual copyright year and provided electronically by ASM. (See Schedule A for a list of the collections and titles included in this Agreement.)

**1.2 Authorized Users.** Any individual who, if Licensee is an academic institution, is a registered student, faculty member, staff member, or affiliated researcher, or, if Licensee is a company or a government entity, is an employee or independent contractor, permitted access to Licensee's Secure Network. An affiliated researcher or independent contractor must be employed, and/or conducting research, physically at Licensee's location. A visitor to Licensee's site who is authorized to use that facility's library network is considered to be an Authorized User. Authorized Users may be remote users so long as they are affiliated with Licensee. Walk-ins (patrons who are not affiliated with the Licensee) may be considered Authorized Users only if they are physically present at the Licensee's site.

**1.3 Commercial Use.** Use of Licensed Materials for the purpose of monetary reward (whether by or for the Licensee or an Authorized User) through the sale, resale, loan, transfer, hire or other form of exploitation of the Licensed Materials. Neither recovery of direct costs by the Licensee from Authorized Users, nor use by the Licensee from Authorized Users of the Licensed Materials in the course of funded research, including research funded by a commercial organization, shall be deemed Commercial Use.

**1.4 Licensed Materials.** The ASM Press eBook Collection(s) selected on the Cover Sheet.

**1.5 Secure Network.** A network (whether a standalone network or a virtual network on the Internet), which is accessible only to Authorized Users approved by the Licensee, requiring the identity of a user to be authenticated at the time of log-in and periodically thereafter consistent with current best practice, and whose conduct is subject to regulation by the Licensee. A proxy server may be included in the network.

**1.6 Single Site.** One geographic location or multiple sites within one city that are part of a single organization unit administered centrally (e.g., different campuses of the same university within the same city). Single Sites are categorized as different tiers based on the following

number of faculty plus individuals in registered doctoral (PhD, MD, DVM, etc.) and postdoctoral programs in the life sciences (if Licensee is an academic institution) or number of employees (if Licensee is a company):

- 1 - 200 (Tier A)
- 201 - 1,500 (Tier B)
- 1,501 - 3,500 (Tier C)

**1.7 Subscription Fee.** The annual fee for nonexclusive access to the Licensed Materials, subject to the terms and conditions of this Agreement.

## **2. License Grant**

**2.1 Use.** Subject to all terms and conditions of this Agreement, Licensor hereby grants to Licensee upon the purchase of the Licensed Materials a limited, nonassignable, nonexclusive Single Site license to access and use the Licensed Materials and the right to sublicense access to and use of the Licensed Materials to Authorized Users, for the period of time set forth in the Cover Sheet, but not for any Commercial Use. Use and access under this license grant shall include the following:

- A. Print; Download; Extraction. Consistent with the Fair Use provisions of Section 107 of the U.S. Copyright Act, Licensee and Authorized Users may display, print, download, extract, share with Authorized Users, or use individual chapters of content contained in the Licensed Materials for educational, scientific, or research purposes, including extraction and manipulation of information for the purpose of illustration, explanation, example, comment, criticism, teaching, research, or analysis.
- B. Electronic Links. Licensees may provide secure electronic links to the Licensed Materials from Licensee's web page(s) to increase the usefulness of the Licensed Materials to Authorized Users. Upon request, Licensor will assist Licensee in creating such links and Licensee shall make changes to the appearance of such links and/or in statements accompanying such links as requested by Licensor.
- C. For library e-reserve or course syllabus purposes, Licensee may provide metadata with appropriate links to one or more individual chapters or articles for Authorized Users to access the full-text format.
- D. Interlibrary Loan: Licensee may download and print individual articles that are faxed, mailed, hand-delivered, or scanned and transmitted electronically to a requester under Licensee's interlibrary loan procedures, so long as the requesting institution is a non-commercial library located in the same country as Licensee. No other form of electronic transmission or forwarding of Licensed Materials is permitted.
- E. Text and Data Mining. Authorized Users are permitted to engage in Text and Data Mining (TDM) meaning: downloading, extracting and indexing information from the Licensed Materials. Where required, TDM includes mounting, loading and integrating the results on a server used for the Licensee's text-mining system and evaluate and interpret the TDM output for access and use by Authorized Users. The Licensee shall ensure compliance with Licensee's obligations set forth in Section 4.2 of this Agreement, including but not limited to security and

technical access requirements. TDM may be undertaken on either locally loaded Licensed Materials or as mutually agreed.

- F. CLOCKSS System. Licensee is authorized to utilize the [CLOCKSS System](#) of archiving in order to preserve the Licensee's use of and access to Licensed Materials in the event that Licensor no longer provides such access as defined by the CLOCKSS triggering event parameters. This permission is granted on the further condition that Licensee installs and maintains, at its own expense, any software or other mechanism and authorizations needed to participate in the CLOCKSS system.

## **2.2 Access**

Authorized Users' access to the Licensed Materials is controlled by valid Internet Protocol ("IP") address(es), or range(s) of IP addresses, which Licensee is responsible for providing. Only the IP address(es) submitted by the Licensee at the time of subscription or at the time of renewal may have access to the Licensed Materials. Addition of IP addresses at any other time must be approved in advance by Licensor and may require additional payment if the addition(s) increases the number of Authorized Users. Licensee may use a proxy server for providing remote dial-in access for its Authorized Users, but the use of an open proxy server is prohibited.

## **3. Ownership of Intellectual Property**

3.1 All right, title and interest in the Licensed Materials and all intellectual property rights related thereto, including but not limited to content, data, trademarks, copyrights, and any derivative works derived therefrom, shall be and remain with Licensor. Neither Licensee nor Authorized Users shall have any right, title or interest in the Licensed Materials nor in any related intellectual property rights except as expressly set forth herein.

3.2 Removal of Copyright Notice. Neither Licensee nor Authorized Users shall remove, obscure or modify any copyright or other notices in the Licensed Materials.

3.3 Modification. Other than as set forth herein, neither Licensee nor Authorized Users shall modify or create a derivative work of the Licensed Materials, in whole or in part, without prior express written permission of Licensor.

## **4. Obligations and Representations and Warranties**

### **4.1 Licensor**

- A. Licensor represents and warrants that to the best of Licensor's knowledge, the Licensed Materials used as contemplated by this Agreement do not infringe the copyright or any other proprietary or intellectual property rights of any third party. Licensor shall indemnify and hold Licensee harmless from and against any loss, damage, costs, liability and expenses (including reasonable legal and professional fees) arising out of legal action taken against Licensee due to an actual or alleged infringement of such rights. This indemnity shall not apply if Licensee and/or Authorized Users have modified or used the Licensed Materials in any way not permitted by this Agreement.

- B. Licensor reserves the right to withdraw from the Licensed Materials any material which it no longer retains the right to publish, or which it has reasonable grounds to believe infringes copyright or is defamatory, obscene, unlawful, or otherwise objectionable. Licensor shall give written notice of the withdrawal to Licensee within sixty (60) days of the removal of any material pursuant to this Section 4.
- C. Licensor shall comply with the American with Disabilities Act (ADA) by supporting assistive software or devices such as large print interfaces, voice-activated input, and alternate keyboard or pointer interfaces in a manner consistent with generally accepted best practices.
- D. Licensor shall make statistics regarding the usage of the Licensed Materials by Licensee and their Authorized Users available to Licensee consistent with generally accepted best practices. Licensor will provide ongoing access to usage statistics on a password-protected site.
- E. Licensor shall use reasonable efforts to provide continuous access to the Licensed Materials. Unavailability may occur related to failure of equipment or services beyond the control of Licensor. Every effort will be made to minimize any downtime and to restore services in the event of a failure beyond the control of Licensor.

## 4.2 Licensee

- A. Licensee agrees to the terms and conditions herein and shall be responsible for compliance with same on behalf of Authorized Users. Licensee represents and warrants that it has the right and authority to enter into this Agreement and act on behalf of the Authorized Users.
- B. Licensee agrees to indemnify and hold harmless Licensor, its officers, directors, employees, members, subcontractors, agents, successors, assigns, affiliates or subsidiaries from and against any claims, actions or demands arising from a breach of this Agreement or from a third party claim of infringement due to the use or creation of a derivative work created by Licensee and/or Authorized User or due to an unauthorized use of the Licensed Materials by Licensee or Authorized User.
- C. Licensee agrees to designate a single person to be the administrator of this Agreement. The name, address, phone number, and e-mail address of the Agreement administrator shall be listed on the Cover Sheet. Licensee shall notify Licensor of any changes to the assigned administrator or contact information.
- D. Licensee represents and warrants that it will use best efforts to notify Authorized Users of the terms and conditions of this Agreement.
- E. Licensee represents and warrants that it will provide access to the Licensed Materials on a Secure Network. Licensee and its Authorized Users shall be granted access pursuant to IP addresses, passwords, public keys or certificates, or other security protocols developed and accepted during the term of this Agreement. Licensee shall provide via separate electronic delivery to Licensor a complete set of valid IP addresses included in Schedule B to enable Licensor to authenticate users and to supply accurate statistics. The form of these IP addresses must be acceptable to Licensor. Only those IP addresses submitted by the Licensee will have access to the Licensed Materials, and Licensee is responsible for promptly notifying Licensor of any changes in the IP addresses. Licensee is responsible for deleting any expired or inaccurate IP address(es) from the subscription account and for taking reasonable measures to prevent access by unauthorized individuals to its authorized

IP address(es).

- F. Detection of Prohibited Uses. Licensee is responsible for taking reasonable measures to prevent prohibited uses and to promptly notify Licensor of any infringements of copyright or prohibited use of which Licensee becomes aware. Licensee will cooperate with Licensor in investigating any such prohibited uses and will take reasonable steps to ensure the cessation of such activity and to prevent any reoccurrence. If Licensor identifies any unauthorized use of the Licensed Materials in breach of this Agreement, Licensor has the right to immediately suspend access under this Agreement for the offending IP Address until the breach is corrected. Licensor and Licensee agree that they will work together to correct the breach as soon as possible so that access can be restored.

### **4.3 Mutual Representations and Warranties**

Both Parties represent and warrant that a) it has the legal authority to enter into this Agreement; b) this Agreement will not conflict with any other contract, agreement or law; c) this Agreement, executed and delivered, will constitute a binding obligation; and d) it shall adhere to Section 8 and all applicable privacy and data protection laws applicable to the gathering, processing, storing and transmitting of all Confidential Information, as defined below.

### **5. Disclaimer of Warranties / Limitation of Liability**

- 5.1 THE LICENSED MATERIALS ARE PROVIDED ON AN "AS IS" AND "AS AVAILABLE" BASIS. LICENSOR EXPRESSLY DISCLAIMS ALL WARRANTIES OF ANY KIND WITH RESPECT TO THE LICENSED MATERIALS, EXCEPT AS MAY BE EXPLICITLY SET FORTH HEREIN, WHETHER EXPRESS OR IMPLIED, INCLUDING IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, TITLE AND NON-INFRINGEMENT. LICENSOR MAKES NO WARRANTY THAT ACCESS TO THE LICENSED MATERIALS WILL BE UNINTERRUPTED, THAT DEFECTS WILL BE CORRECTED, OR THAT THIS SITE OR THE SERVER THAT MAKES IT AVAILABLE ARE FREE OF VIRUSES OR OTHER HARMFUL COMPONENTS. THE LICENSED MATERIALS MAY CONTAIN OUTDATED OR DEAD LINKS WITHIN THE TEXT THAT ARE OUTSIDE OF LICENSOR'S CONTROL AND FOR WHICH LICENSOR WILL NOT BE HELD RESPONSIBLE. LICENSOR DOES NOT WARRANT OR MAKE ANY REPRESENTATIONS REGARDING THE USE OR THE RESULTS OF THE USE OF ANY LICENSED MATERIALS IN TERMS OF CORRECTNESS, ACCURACY, RELIABILITY, OR OTHERWISE. LICENSEE AND AUTHORIZED USERS ASSUME ALL RESPONSIBILITIES AND OBLIGATIONS WITH RESPECT TO THE SELECTION OF LICENSED MATERIALS TO ACHIEVE INTENDED RESULTS. LICENSEE AND AUTHORIZED USERS ASSUME ALL RESPONSIBILITIES AND OBLIGATIONS WITH RESPECT TO ANY DECISIONS OR ADVICE MADE OR GIVEN AS A RESULT OF THE USE OR APPLICATION OF ANY LICENSED MATERIALS, INCLUDING THOSE TO ANY THIRD PARTY. THE LICENSED MATERIALS ARE FOR INFORMATIONAL PURPOSES ONLY AND ARE NOT INTENDED TO REPLACE OR SUBSTITUTE FOR ANY MEDICAL OR OTHER PROFESSIONAL ADVICE.

- 5.2 Although care has been used in the accuracy, completeness, or functioning of the Licensed Materials, Licensor assumes no responsibility for the Licensee's or Authorized Users' use thereof and shall not be liable for loss of profits, loss of use, or incidental, consequential, or exemplary damages as a result of such use, even if aware of the possibility thereof.
- 5.3 No computer software is delivered as a part of this Agreement, and this Agreement is not conditional upon Licensee's ability to provide its own software or the ability to use the Licensed Materials provided under this Agreement.
- 5.4 IN NO EVENT SHALL LICENSOR BE LIABLE FOR MORE THAN THE FEES PAID BY LICENSEE UNDER THIS AGREEMENT. IF LICENSEE IS DISSATISFIED WITH THE LICENSED MATERIALS OR ANYTHING ELSE RELATED TO THIS AGREEMENT, LICENSEE'S SOLE AND EXCLUSIVE REMEDY IS TO TERMINATE THIS AGREEMENT AND DISCONTINUE USE OF THE LICENSED MATERIALS.

## 6. Payment

6.1 The fees due under this Agreement are set forth on the Cover Sheet. Licensor shall invoice Licensee for the Subscription Fee with payment due within thirty (30) days receipt of invoice. Subsequent renewals will be invoiced in the same manner with the same 30-day payment term. Licensor's current fee schedule is available from Licensor upon request. Licensor shall provide notice of any change in the Subscription Fees to Licensee at least ninety (90) days before the end of the then-active term.

## 7. Term and Termination

**7.1 Term.** The term of this Agreement shall be as set forth on the Cover Sheet. This Agreement shall automatically renew for an additional one-year term unless Licensee notifies Licensor in writing of its intention not to renew at least thirty (30) days prior to the expiration of the then-active term.

**7.2 Termination.** This Agreement shall terminate under the following scenarios:

- A. Licensor may terminate if Licensee does not pay the fee(s) set forth on the Cover Sheet and described in Section 6 or breaches the obligations set forth in Sections 4.2, 4.3 or 8. Termination shall be effective upon thirty (30) days notice to Licensee. In the event of termination pursuant to this Section 7.2(A), no refund or partial refund of fees will be given.
- B. In the event that Licensee is a government-sponsored institution, Licensee may terminate upon thirty (30) days written notice if Licensee fails to receive, beyond Licensee's control, expected appropriation funding from its respective legislative body that Licensee was intending to use for this Agreement.
- C. Pursuant to Section 7.1, Licensee may also terminate upon giving thirty (30) days written notice prior to the expiration of the then-active term.
- D. Either Party may terminate without cause within the first thirty (30) days following the Effective Date. Termination shall be effective immediately upon written notice to the other Party.

- E. If termination occurs pursuant to Sections 7.2(B), 7.2(C), or 7.2(D), Licensor shall refund a pro-rated amount of the Subscription Fee, if applicable, paid for the then-active term.

**7.3 Effect of Termination.** Upon termination for any reason other than a breach by Licensee, Licensee shall be entitled to keep a permanent flat file (.PDF) copy of the Licensed Materials. Also upon termination, any links to Licensed Materials under Sections 2.1(B) and (C) shall be removed.

## **8. Confidential Information**

8.1 Each Party acknowledges that, in connection with the performance of this Agreement, it may receive certain confidential or proprietary technical, business or financial information and materials of the other Party or data related to the usage of the Licensed Materials by Licensee and Authorized Users ("Confidential Information"). Confidential Information shall include the disclosing Party's service offerings, methodologies, software, product documentation, data, legal strategies and work product, and any other business, financial or technical information that is marked or otherwise identified as confidential or proprietary.

8.2 Both Parties agree (a) to use the other Party's Confidential Information only for the purposes described in this Agreement; (b) not to reproduce the other Party's Confidential Information and will hold in confidence and protect such Confidential Information from dissemination to, and use by, any third party; and (c) to restrict access to the other Party's Confidential Information to such of its personnel, agents, suppliers and/or consultants, if any, who have a need to have access and who have been advised of and have agreed in writing to treat such information in accordance with the terms of this Agreement. Both Parties agree that all Confidential Information is proprietary to the disclosing Party or such third party, as applicable, and shall remain the sole property of the disclosing Party or such third party.

8.3 Notwithstanding the foregoing, each Party may disclose Confidential Information (a) if expressly authorized in writing by the subject of that information; (b) in response to an order of a court or other governmental body; (c) as required by law or regulation to be disclosed; or (d) in order to establish a Party's rights under this Agreement.

8.4 If either Party breaches this Section 8, the non-breaching Party will suffer irreparable harm, the total monetary damages for which will be impossible to calculate and therefore inadequate. Accordingly, the non-breaching Party may a) seek appropriate injunctive relief against the breaching Party or b) exercise any other rights and seek any other remedies to which the non-breaching Party may be entitled at law, in equity and under this Agreement.

## **9. General**

**9.1 Entire Agreement.** This Agreement incorporates the Cover Sheet and the attached Schedules and sets forth the entire agreement and understanding between the Parties with respect to the subject matter thereof and supersedes and merges all prior oral and written agreements, discussions and understandings between the Parties.



- 9.2 Modification.** No modification or amendment of this Agreement shall be binding upon either Party unless it shall be in writing and signed by persons authorized to bind the Parties to this Agreement.
- 9.3 Assignment.** Licensee may not assign or transfer its rights under this Agreement without the prior written permission of Licensor.
- 9.4 Severability.** If any one or more of the provisions of the Agreement shall for any reason be held to be invalid, illegal or unenforceable, the same shall not affect the validity or enforceability of any other provisions of the Agreement.
- 9.5 Force Majeure.** Neither Party's delay or failure to perform any provision of this Agreement as result of circumstances beyond its control (including, without limitation, war, strikes, floods, governmental restrictions, power, telecommunications or Internet failures, or damage to or destruction of any network facilities) shall be deemed to be, or give rise to, a breach of this Agreement.
- 9.6 Good Faith Resolution.** If there are any disputes or disagreements regarding the terms and conditions of this Agreement, both Parties agree to work in good faith to resolve the issues.
- 9.7 Governing Law; Venue.** This Agreement shall be governed by and interpreted in accordance with the laws of the District of Columbia, without regard to its principles regarding conflicts of law. Each Party hereby irrevocably submits to, and waives any objection to, the exclusive personal jurisdiction of the state and federal courts located in the District of Columbia.
- 9.8 Survival.** The provisions of Sections 3, 4.2, 4.3, 5, 7.3, 8 and 9 shall survive the termination or expiration of this Agreement.
- 9.9 Non-discrimination.** The parties agree to comply with all applicable laws, rules, regulations, and executive orders governing equal employment opportunity, immigration, non-discrimination, including the Americans with Disabilities Act, and affirmative action. The vendor for the ASM Journals Online complies with the W3C Priority 1 international standards for accessibility and has represented to ASM that compliance with Section 508 of the Americans with Disabilities Act was completed in late 2007.
- 9.10 Government Requirements.** ASM complies with all provisions of the Federal Acquisition Regulation (FAR) clauses applicable to the goods and services licensed pursuant to this Agreement.
